INFORMATION COLLECTION AND USE

Next Level collects certain information from our website users. By submitting personal information to Next Level, you agree that Next Level may use such information in accordance with the terms of this Privacy Policy. However, Next Level may share such information with Next Level affiliates, partners, vendors, or contract organizations, or as legally necessary. Next Level will not collect personal information without your knowledge during your visit to our website. Any information that is requested will typically be in direct correlation to the services you are requesting or for purposes of maintaining statistics. From time to time, Next Level may ask for your personal input and suggestions related to your online experience. This information will remain confidential and will allow us to improve and enhance your online user experience. By providing such information, you consent to Next Level's use of such information to better serve you and others coming to our website. SECURITY

We strive to ensure the security of any information you provide. When you submit sensitive information via the website, your information is protected both online and offline. We also protect your information offline. Only employees who need your sensitive information to perform a specific job (i.e. billing or customer service) will be granted access to such information. The computers/servers in which we store personally identifiable information are kept in a secure environment.

COOKIES

A “cookie” is a small piece of data that can be stored by a website onto your computer. Next Level uses cookies in order to enhance your online user experience. Next Level uses both session cookies and persistent cookies. A persistent cookie is stored on your hard drive for an extended period of time. You can remove persistent cookies by following Internet browser help file directions. Your browser may recognize when a cookie has been sent to your system and will give you an opportunity to allow or refuse it. These cookies are used to identify you as a registered user and to allow you to access your site information. We do not use cookies to track your activities on our website.

LOG FILES
